Packing Information: Standard package quantities are shown in the product list.

Shipping Terms: Prices are FOB Shakopee and Brooklyn Park yards for stock materials. Customer trucks for plant pick up orders should have open tops, drop down sides, flat open trailers for mechanical loading. Wheeler Yard Hours of Operation are 7:00 AM to 4:00 PM, Monday – Friday. Wheeler Truck freight rate is \$225.00 per hour, prepaid, anywhere in the Twin Cities Metro Area. Deliveries outside the Metro Area are available. Maximum load for Wheeler Truck is 27,400#. Customer is responsible for unloading all materials. \*Flatbed with Moffett (up to 43,000#) deliveries are available upon request. Please call for quote and lead time.\*

Material: If a product purchased from Wheeler is defective or does not meet our published specification and our customer gives notice to Wheeler before installing the product, Wheeler will replace without charge to our customer or refund the purchase price at Wheeler's election.

Special Order / Returned Goods: NON-STOCK ITEMS ARE SPECIAL ORDER, THERE WILL BE NO RETURNS. All returned merchandise will not be accepted without prior authorization by Wheeler. Product must be full pallets, original packaging, unopened. Product is subject to restock fees based on manufacturer's approval and return policy. Up to a 50% restock fee on product not returnable to manufacturer or out of manufacturer's return policy.

Conditions of Acceptance: All orders are subject to acceptance by our office. Price, discounts, and terms are subject to change without notice. All orders accepted will be shipped on the basis of prices prevailing at the time of shipment.

Terms of Payment: The terms of payment are Net 30 except for early order discounts and direct sales where no 10 Day discount may apply. The above terms are only for customers with established lines of credit. All other orders will be strictly COD. Net cash upon delivery or pick-up. Wheeler reserves the right for a credit check or certified funds in advance before shipping COD orders.

Late payment Penalty Charge: A charge of 1-1/2% per month (18% per year) or the maximum rate permitted by law, whichever is less, will be imposed on past due accounts.
